## iGO eApplication Update: Agent Report Screen Changes Effective March 8

Our iGO e-application system will soon transition to a new environment that will set the stage for improved connectivity and features. As we prepare for the transition, some minor changes will be made to the **Agent Report screen** as noted below. **These changes are effective March 8, 2019.** 

### Agent Report Screen: What's Changed?

Previous Agent Report screen is at right; new screen effective 3/8 is shown below.

- 1. Service # field renamed to Agent Code.
- 2. LO Code and Agency fields combined into one Agency Code field.
- Question removed: "Will the Writing Agent have a different Service # to receive the commission for this policy?"

Instead, you may now type the appropriate Agent Code and Agency in the Writing Agent section if you want to specify a different number to receive the commissions for the policy.

As we transition to a new iGO environment, changes noticed by users should be minimal and we will keep you posted well in advance.
