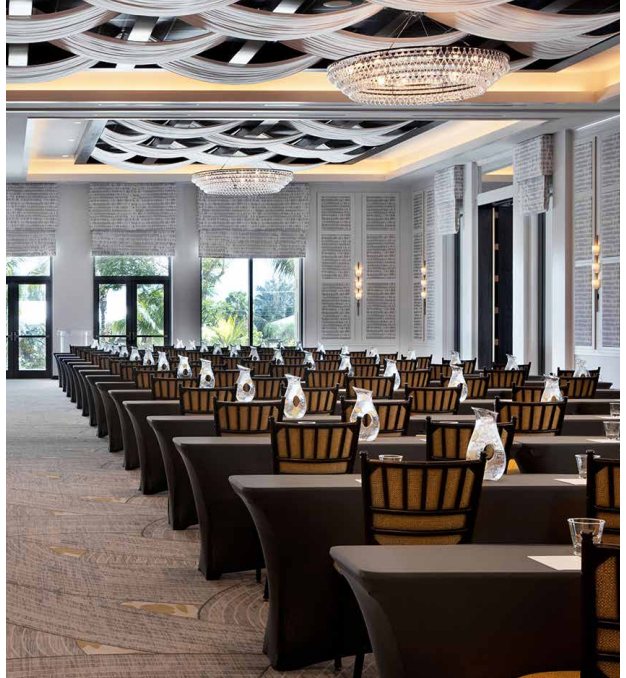
## NET-WEIGHTED LIFE PREMIUM

Term.....	100%
UL/IUL/GUL up to and including Target.....	100%
UL/IUL/GUL Excess Target.....	10%

\* Paid Net-Weighted First-Year Life Premium equals American General Life Insurance Company (AGL) annualized target first-year premium plus 10% of excess premium paid during the first year in excess of target. Reversals will apply for free-look, early lapse and not-taken policies. To be counted toward qualification, the policy must have initial premium applied to put the policy in force.

## OTHER DETAILS

- Qualification includes one guest.
- Production credit based on Paid Net-Weighted First-Year Life Premium from January 1, 2020 – December 31, 2020.
- Policies written on the agent's own life or the lives of family members may be excluded.
- AIG Min Placement Rate Definition: Must place in force 50% or higher of policies applied for to qualify for this program. If the agency or agent has a placement rate below 49.99%, they will not qualify.
- Placement rate and persistency tracking available to MGAs on Connex website. Contact your MGA or the Partners Group sales desk with any questions.
- At our discretion we reserve the right to exclude Leaders Conference qualification for agents and MGAs with poor persistency.
- Only agents actively contracted and appointed by and in good standing with AGL at the time of the trip are eligible to participate.
- Registration will be available only to those who qualify and are invited by the Company to attend. Attendance at the Business and Recognition sessions is mandatory for all qualifiers. Guests of qualifiers will not be permitted to register on site unless accompanied by the qualifier.
