What Training is required?

If you are in an NAIC State, 2 Training courses need to be completed:

- 1) AEI Product-Specific Training, and
- 2) Your state 4-Hour* CE Annuity Suitability Model Law Training (see attached list of states which have adopted the NAIC Suitability Rule)

If you are not in an NAIC State: AEI Product-Specific Training is required

Where can I complete the training?

Contracted Agents: If you are already contracted at American Equity to sell annuities, please go to: <u>www.american-equity.com</u>.
