<sup>2</sup> AIC sales will be credited at 75% of Gross Dealer Concession and are limited to 30% of respective Club requirement. AIC GDC qualification credits for sales to Massachusetts clients or by Massachusetts financial professionals are limited to variable insurance product commissions and advisory fees.

<sup>3</sup> Extra day (April 22) at Leaders Conference is extended to Inner Circle exclusively.

<sup>4</sup> Eligibility for the Agent Non-Contributory Deferred Compensation Plan is awarded at Leaders Court qualification level and above.

<sup>5</sup> Veteran status is defined as the sum of the age plus years of conference qualification to equal 75 or more. The minimum age must be at least 60 and the cumulative years of club qualification must be a minimum of 10 for a combined total of 75.

<sup>6</sup> Associate status is defined as individuals new to the industry and eligible for new agent financing programs. Associates must also have satisfied his/her Agent Contract production requirement.

## **Reduction in Required Production allowed in 2022**

The requirements in the charts above can be reduced by 5% if the associate has qualified for Leaders Conference 10+ years.

## **Conference Production Crediting**

- Individual life and DI will receive 100% of FYC.
- Group dental and vision insurance will be credited at 100% paid first year commissions.
- Fixed annuities will be credited at 3% of commissionable deposits.
- Representatives affiliated with outside Broker/Dealers must qualify for non-cash benefits based exclusively on the fixed life and annuity business offered through affiliates of Ameritas. Necessary adjustments will be made at year end to exclude variable products.

Please Note: The production credit formula differs from Agent Contract validation.
