Key Year-End Dates	
Thu, Dec 4	Forward Dated, Conditionally Issued Term Policies  Last day to conditionally issue and forward date Term policies, where the effective and draft date will be Friday, December 26. All delivery requirements must be received by December 26 for policy to be placed inforce.  Note: For California policies, the last date to conditionally issue is Tuesday, November 25 due to extended forward-dating timeframe mandated by state.
Fri, Dec 19	1099 Commission Value (Bi-Weekly and Semi-Monthly) Cut-off date for agents on bi-weekly and semi-monthly pay frequency. • Semi-monthly and bi-weekly payroll released Tuesday, Dec. 23.
	Underwriting Approval – All Products  Last date for underwriting approval of all products to obtain policy issue and inforce placement prior to December 26th Corebridge commission cutoff.  Please note: This assumes no other delivery requirements, current effective date, draft date, or other form of premium on file. Underwriting approvals will continue through year-end. Escalate any case to your Case Manager or Internal Wholesaler as needed.
	Delivery Requirements — All Cases  Last receipt date for delivery requirements to ensure placement in 2025.
	1035 Exchanges  Last date to receive 1035 funds and have policies issued and placed inforce, assuming all other requirements, including signed amendments and signed illustrations, have been received.
Fri, Dec 26	1099 Commission Value (Weekly)  Cut-off date for agents on weekly pay frequency.  Note: Weekly payroll released Tuesday, Dec. 30.
